The Round Lake Area Park District is currently seeking candidates for park board commissioner for the April 1, 2025, consolidated Election. The office of park board commissioner is non-partisan and interested candidates can pick-up nominating packets at the Robert W. Rolek Community Center located at 814 Hart Road, Round Lake, Illinois.

The Round Lake Area Park District will have one – 6 year full-term seat and one – 4 year term seat available. No person shall be eligible to serve as park commissioner unless that person is a qualified elector of the park district as has resided within the District at least one year prior to election or appointment.

Candidate packets can be picked up at the Robert W. Rolek Community Center during the Guest Services Office hours of 8:00 a.m. to 4:00 p.m., Monday through Friday.

All completed nomination papers should be filed at the Robert W. Rolek Community Center located at 814 Hart Road, Round Lake, Illinois. The dates and hours for filing nomination papers are as follows:
