The Round Lake Area Park District is committed to conducting its recreation programs and activities in a safe manner and holds the safety of participants in high regard. The Round Lake Area Park District continually strives to reduce such risks and insists that all participants follow safety rules and instructions that are designed to protect the participant's safety. However, participants and parents/guardians of minors registering for the listed programs/activities must recognize that there is an inherent risk of injury when choosing to participate in recreational activities/programs.

You are solely responsible for determining if you or your minor child/ward are physically fit and/or skilled for the activities contemplated by this agreement. It is always advisable, especially if the participant is pregnant, disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity.

To people who are not sufficiently skilled, paddling can be dangerous or even fatal. Safe paddling demands that people keep to water conditions that are appropriate for their skills, paddling tips include: you should never paddle alone; carry a throw rope or a rescue bag; always wear a helmet and a life jacket or personal floatation device; check water levels and the difficulty of your route before setting out; scout all unfamiliar rapids for hazards, beware of heavy run-off and spring floods; and learn self-rescue techniques, including how to maneuver upstream of a drifting boat

Warning of Risk

Paddling is intended to challenge and engage the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including drowning. Understandably, not all hazards and dangers can be foreseen. Certain risks include, but are not limited to, exceeding your level of ability; submerged paddler being pinned between rock and the overturned, water-filled boat; kayak/canoe getting pinned on rocks, logs, or trees; extremely high run-off; striking your head on submerged rocks; hypothermia; dangerous weather and water conditions such as rapids, deep or cold water; surface and subsurface rocks and obstacles; hydraulics, strainers and ledges; acts of God; insect bites; heatstroke or dehydration; inadequate supervision or instruction; recklessness, carelessness or horseplay; poorly maintained equipment, and poor paddling technique or swimming skills. In this regard, it is impossible for the Round Lake Area Park District to guarantee absolute safety.

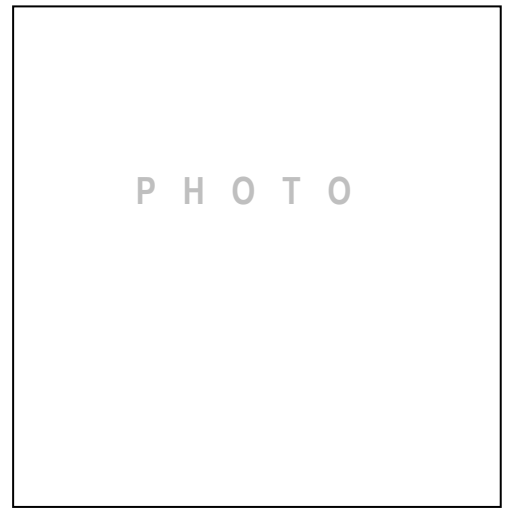

He was an advocate for fishing, recreation, and the conservation of our community. Through the assistance of the Huebner Fishery Management Foundation and John Huebner's vision, the Round Lake Area Park District strives to provide fishing programs for any age or skill level, a reasonably diverse fish population, public education of boating safety and instruction, and a safe environment to enjoy recreational activities on the water. In this 2-day camp, teens will learn how to safely navigate a canoe and kayak! By the end, they will understand the fundamentals and safety, along with some lake ecology and we'll use games to reinforce these skills! Last day of camp we will attempt to voyage around Round Lake. Camp packet to be picked up and filled out. Equipment to be provided includes: PFD's, boats, paddles.

Day 1: **Getting to Know:** Equipment, gear, proper techniques of paddling, getting into the lagoon!

Parent Information Please Read:

As your child prepares for camp, there are a few key things to remember to help make his/her experience the best that it can be:

- *Drop-Off / Pick-Up*

On the day of camp, campers should be dropped off no earlier than 4:15 p.m. and signed-in upon arrival at 1331 Round Lake Drive, Round Lake Beach. Each afternoon campers will need to be picked up and signed-out at 6:40 p.m. Please list all acceptable persons who may sign-out your child on the *Emergency Contact/Pick-Up* form. ***Before or After Care will not be offered.***

- *Clothing*

Required: T-shirt/tank top, shorts/pants, closed toed shoes or sandals that stay on feet, water bottle.

Encouraged to Bring: Sunglasses, towel, extra clothes, hat, polyester synthetic clothing, snacks, sunscreen.

Optional: Wearing a swimsuit underneath clothing.

**Note: Hypothermia can occur during summer hours should your camper get wet. It is advised to wear polyester, synthetic, spandex, or other similar material versus cotton when in and around the water.*

- *Weather*

If inclement weather roles into the forecast, camp will be canceled. Refunds will be provided for cancelled days.

- *Water*

Iced water will be provided on-site in coolers.

- *Contact Us*

We want your child to have the best possible experience, so please feel free to contact us with any questions, concerns, or special considerations we should know about.

- *Sunscreen / Insect Repellent*

Please make sure your child has sunscreen on before coming to camp. Staff will also have child-friendly sunscreen and insect repellent available for reapplication during the day for campers.

BEHAVIORAL CONTRACT #4**

The Round Lake Area Park District has adopted the Behavior Management Program called P.B.I.S. – Positive Behavior Intervention Strategies. P.B.I.S. assists us in creating a culture that encourages positive behavior and interactions, while discouraging problematic behavior. The process focuses on expectations, rather than rules; however there are still rules in place. The expectations set by the park district are: *Be Ready, Be Safe, Be Kind*. Staff will use a positive approach to behavior management; please refer to the Parent Handbook for the detailed policy. If inappropriate or unacceptable behavior occurs, prompt resolution will be sought using the steps outlined below.

A). General Unacceptable / Inappropriate Behaviors

- 1). Any aggressive behavior, (slapping, punching, kicking, biting, etc.), whether it is initiated or in retaliation.
- 2). Any disrespectful behavior toward staff and/or other participants.
- 3). Continuous disruptive behavior.
- 4). Any swearing or inappropriate language.

B). Routine Procedures

1). *First Warning*

The first time any inappropriate/unacceptable behavior occurs, the parent will be notified by phone, or written letter. If that behavior occurs again that day, the parent(s) will then be called to come and remove the child from the program for the remainder of that day.

2). *Second Warning*

If a child continues to display any unacceptable/inappropriate behavior after a first warning has been given, the child will then receive a written note of the second warning. This note will state the unacceptable/inappropriate behavior of the child and notify the parent(s) that one more incident of such behavior could lead to possible removal from the program. This letter must be signed by a parent and returned to the Director the next day of school.

3). *Third and Final Warning*

After a first and second warning have been issued and an inappropriate behavior is once again displayed, the parent(s) will be contacted by phone and in a written notice that their child must be removed from the program for a certain period of time or permanently, depending on the severity of behavior.
